ATTENTION! Revised Fee Schedule Enclosed

Included with this newsletter is a Revised Fee Schedule. The changes are highlighted in bold text and will be effective August 15, 2015.

Also beginning on August 15, 2015, the minimum balance required to earn a dividend on a Kid's Account will be \$100 (the same as all other share accounts).

Call PAT (Personal Automated **Teller - Phone)**

Did you know that with the telephone you can get the balance on your account, find out if a deposit has been made, or see if a check has cleared? PAT, your Personal Automated Teller, is standing by 24 hours a day, 7 days a week to give you information on vour account.

The number to reach PAT has recently been changed with our new computer conversion. You can now call 855-327-8910 or select the option for PAT when you call our main number.

While PAT only speaks English and Spanish right now, very shortly she will speak Vietnamese as well.
